B. Information We Collect Automatically

- Website interactions, clicks, and pages visited.
- Cookies and tracking technologies for analytics and session management.

C. Information from Third Parties

We may receive additional information from:

- Payment processors or service providers.
- Marketing partners or analytics tools.

- Publicly available business listings or aviation directories.

3. How We Use Your Information

We use the information we collect to:

BID-A-FLIGHT may share limited user information in the following circumstances:

- **With Operators or Users:** When connecting passengers and FBOs for flight bids or offers.
- **With Service Providers:** For hosting, analytics, payment processing, or email delivery.
- **For Legal Compliance:** When required by law, subpoena, or government request.
- **In Business Transfers:** If BID-A-FLIGHT is merged, acquired, or restructured, user data may transfer as part of that transaction.

We do **not sell** your personal information to third parties for profit.

5. Cookies and Tracking Technologies

BID-A-FLIGHT uses cookies and similar tools to:

- Maintain your login session.
- Analyze site usage and performance.
- Customize user experiences.

You can manage or disable cookies through your browser settings, but doing so may limit some features of our platform.

6. Data Security

We implement industry-standard administrative, technical, and physical safeguards to protect your data.

However, no online system is completely secure, and we cannot guarantee absolute security.

7. Data Retention

We retain your information only as long as necessary to:


- Provide the Services;
 - Comply with legal or accounting requirements; or
 - Resolve disputes and enforce agreements.
