

# BID-A-FLIGHT – Terms of Service

## 1. Acceptance of Terms

By accessing or using the BID-A-FLIGHT website, platform, or services (“Services”), you agree to be bound by these Terms of Service and all applicable laws and regulations.

If you do not agree with these terms, you may not use our Services.

## 2. Nature of Our Services

BID-A-FLIGHT is an **online marketplace and referral platform** that allows passengers (“Users”) to post flight requests and **Fixed Base Operators (FBOs), charter operators, and other aviation providers (“Operators”)** to respond with offers or counteroffers.

BID-A-FLIGHT **does not own, operate, or manage aircraft**, nor do we act as an air carrier, air charter broker, or agent for any User or Operator.

All flight arrangements are made **directly between Users and Operators**.

## 3. No Air Carrier or Broker Status

BID-A-FLIGHT is **not a direct or indirect air carrier, air taxi operator, or air charter broker** as defined by the U.S. Department of Transportation (DOT) or Federal Aviation Administration (FAA).

We **do not control or operate flights, do not hold out air transportation, and do not accept payment on behalf of any Operator or User** for flight services.

Any flight services offered or performed are the **sole responsibility of the Operator**, who must hold all required FAA and DOT certifications.

---

## 4. Platform Use

- Users may post flight requests and receive offers or counteroffers from Operators.
- Operators may post availability, respond to bids, and list aircraft and services.

- BID-A-FLIGHT may charge **listing fees, posting fees, or subscription fees** to Operators or Users as part of its platform operations.
  - BID-A-FLIGHT does **not guarantee** that a flight request will result in an accepted offer or completed flight.

## 5. Payments

All payments for flight services are to be handled **directly between Users and Operators**. BID-A-FLIGHT may charge **service or posting fees** to facilitate platform operations, but BID-A-FLIGHT **does not handle or transfer any flight-related funds** between Users and Operators.

## 6. User Responsibilities

All Users and Operators agree to:

- Provide accurate and truthful information.
- Comply with all applicable laws, regulations, and aviation standards.
- Not post false, misleading, or fraudulent information.
- Not use the platform for unlawful purposes or activities.

Operators are solely responsible for maintaining all necessary **FAA/DOT certifications, insurance, and compliance**.

---

## 7. Disclaimers

BID-A-FLIGHT provides its platform “**as is**” and “**as available**” without warranties of any kind, either express or implied.

We make **no guarantees** about the accuracy, safety, legality, or quality of any flight services offered through the platform.

BID-A-FLIGHT is **not responsible** for:

- The performance, safety, or conduct of any Operator or User.
  - Flight delays, cancellations, or incidents.
  - Any damages or losses resulting from use of the platform or third-party services.
- 

## 8. Limitation of Liability

To the fullest extent permitted by law, BID-A-FLIGHT, its officers, directors, employees, and affiliates shall **not be liable** for any direct, indirect, incidental, consequential, or punitive damages arising from:

- Use of or inability to use the platform;
- Flight services performed by third parties;
- Any disputes between Users and Operators.

Total liability of BID-A-FLIGHT shall in no case exceed the amount paid by you to BID-A-FLIGHT in the 12 months preceding the claim.

## **9. Indemnification**

You agree to indemnify and hold harmless BID-A-FLIGHT, its affiliates, and employees from any claims, damages, liabilities, or expenses arising from:

- Your use of the platform,
  - Your violation of these Terms, or
  - Any disputes or claims related to flights or services you arrange through the platform.

All content, design, logos, and trademarks displayed on BID-A-FLIGHT are the property of BID-A-FLIGHT, Inc. or its licensors.

You may not copy, reproduce, or use any part of the platform without prior written consent.

## **11. Termination**

BID-A-FLIGHT reserves the right to suspend or terminate any account or access to the platform for any reason, including violation of these Terms or misuse of the platform.

BID-A-FLIGHT may update these Terms from time to time.
